## 2. Filling rules

This guidance for the national annex of the Netherlands, builds on the guidance of the SRB. Where relevant, reference is made to the previous national data points list (Fourth Bail-In Data Points List, 'FBIDP'). For each data point, it is indicated between square brackets whether or not this data point was part of the FBIDP, and in what column this data point was to be reported.

### 2.1. Tab B02.00

#### 2.1.1. c0038: Multiple ISINs? [FBIDP c0041]

Please indicate if the instrument has multiple ISIN codes, for example in case of listings in multiple locations.

- TRUE;
- FALSE.

#### 2.1.2. c0039: If so what ISIN? [FBIDP c0042]

If previous data point is completed with answer 'TRUE', the Resolution Entity should insert the additional ISIN-code unique 12-digit identifier used.

#### 2.1.3. c0106: Current Coupon (%) [FBIDP c0690]

Level of the coupon that is applicable to the instrument at the reporting date. Notation shall be done in absolute value, where 1 equals 100% and with minimum 4 decimal numbers detail.

#### 2.1.4. c0107: Frequency of coupon payments [FBIDP c0710]

Indicate the frequency of coupon payments:

- Annual;
- Semi-annual;
- Quarterly.

#### 2.1.5. c0108: Day count convention [FBIDP c0730]

Indicate the day count convention indicated in the applicable final terms used to calculate the amount of due and payable interest. Choose from:

- 360;
- 365.

**2.1.6. c0109: Business day convention [FBIDP c0740]**

Indicate the business day convention used in the applicable final terms of the instrument, whereby payment days fall on a holiday or a Saturday or a Sunday. Choose from:

- Preceding business day;
- Next business day;
- Nearest business day;
- No adjustment.

**2.1.7. c0148: Alternative CET1 instruments**

Choose from:

- American Depositary Receipts;
- Member certificates;
- Depository receipts;
- Not applicable.

**2.1.8. c0149: Aggregate nominal value of alternative CET1 instruments [FBIDP c0140]**

If applicable, related to the alternative CET1 instruments of c0148.

**2.1.9. c0389: Definitive notes issued [FBIDP c1070]**

Indicate "TRUE" if a physical form of the instrument has been issued after the instrument was originally issued in dematerialized form. Otherwise indicate "FALSE".

- TRUE;
- FALSE.

**2.1.10. c0472: Fiscal Agent [FBIDP c1090]**

If applicable, the legal entity which performs the function of fiscal agent for the relevant instrument. Please state the full legal name as recorded in the relevant corporate registry of the jurisdiction in which it is incorporated, including the indication of the incorporation form.

**2.1.11. c0473: Fiscal Agent (LEI) [FBIDP c1091]**

When applicable, please indicate the LEI code (or another ID) of the fiscal agent.

**2.1.12. c0474: Issuing Agent [FBIDP c1100]**

If applicable, the legal entity which performs the function of issuing agent for the relevant instrument. Please state the full legal name as recorded in the relevant corporate registry of the jurisdiction in which it is incorporated, including the indication of the incorporation form.

**2.1.13. c0475: Issuing Agent (LEI) [FBIDP c1101]**

When applicable, please indicate the LEI code (or another ID) of the issuing agent.

**2.1.14. c0476: Listing Agent [FBIDP c1110]**

If applicable, the legal entity which performs the function of listing agent for the relevant instrument. Please state the full legal name as recorded in the relevant corporate registry of the jurisdiction in which it is incorporated, including the indication of the incorporation form.

**2.1.15. c0477: Listing Agent (LEI) [FBIDP c1111]**

When applicable, please indicate the LEI code (or another ID) of the listing agent.

**2.1.16. c0478: Transfer Agent [FBIDP c1120]**

If applicable, the legal entity which performs the function of transfer agent for the relevant instrument. Please state the full legal name as recorded in the relevant corporate registry of the jurisdiction in which it is incorporated, including the indication of the incorporation form.

**2.1.17. c0479: Transfer Agent (LEI) [FBIDP c1121]**

When applicable, please indicate the LEI code (or another ID) of the transfer agent.

**2.1.18. c0487: Exchange Agent [FBIDP c1080]**

If applicable, the legal entity which performs the function of exchange agent for the relevant instrument. Please state the full legal name as recorded in the relevant corporate registry of the jurisdiction in which it is incorporated, including the indication of the incorporation form.

**2.1.19. c0488: Exchange Agent (LEI) [FBIDP c1081]**

**2.1.23. c0529: Issued under Reg S, 144A, 3(a)(2) or SEC registered [FBIDP c1050]**

- SEC registered;
- Not applicable for non-USD instruments.

**2.1.24. c0549: If own funds, agro of the liability/instrument [FBIDP c0210]**

To the extent relevant under (national) GAAP, indicate the bond premium classified in capital reserves. Indicate the amount in EUR.
